NOTICE FOR CONCESSION IN TUITION FEES for B.E. students

Students admitted against category: GEN/PH/FF/ESM desirous of claiming 50% concession in tuition fees for the academic year 2024-25 (Even semester-July to November 2024) should apply for 50% concession in the prescribed form ACAD/CON-I (attached below) and submit the application on **on or before 13/7/2024** to the academic section along with Income Certificate in original for the year **2023-24** as per the guidelines and format given in the prospectus, **provided the income of both the parents from all sources does not exceed Rs. 3 lakhs per annum.** Direct admission students (admitted for semester III) have to submit a copy of residence certificate alongwith the application, if student is unable to produce the required income certificate in prescribed format and with in time, then he/she shall pay full amount of tuition fees.

The candidates belonging to reserved category i.e. SC/ST/OBC(non creamy layer) but admitted under General Category are eligible for 50% concession, subject to submission of valid caste certificate and residence certificate.

Concession shall be given for both the semesters (Academic year 2024-25).

8.2 CONCESSIONS IN TUITION FEES**FOR SC, ST, OBC, IN GOVERNMENT COLLEGES ONLY**

Govt. of Goa offers concession in the **Tuition Fee** (only) to the students pursuing professional education, having continuous residence in Goa for 10 years or more, preceding the date of application, and admitted in the Government Institutions as follows:

1. **The candidates belonging to reserved category i.e SC/ST/OBC shall be eligible for 50% concession in fees for a minimum prescribed period of course of study.**
2. Candidates admitted against the seats reserved for the category of **FF/PwD/ESM** shall be eligible for concession of 30% for a minimum prescribed period of course of study.
3. Candidates admitted against the seats of **General, PwD, FF & ESM**, categories only shall be eligible for concession of 50% for a minimum period of course of study, provided the income of both the parents from all the sources does not exceed **Rs. 3,00,000/- per annum.**
4. Maximum concession offered under any of above clauses shall not exceed 50%. (Combination of two clauses not permitted). There shall be no concession in unaided colleges for any category, or for the students of States other than State of Goa.

Note:

1. **Admitted candidates belonging to SC/ST categories are advised to obtain details of Fee Waiver Scheme notified by Directorate of Higher Education for SC/ST students pursuing Higher Education and avail the same through the Institution in which they are admitted.**
2. **Admitted candidates may obtain details on “Dayanand Bandodkar Scheme for Higher Education for orphans” notified by Directorate of Higher Education and avail the same through the Institution in which they are admitted.**

MODE OF AVAILING CONCESSION

To avail concession as above, an applicant shall follow procedure as under:

1. An applicant admitted under category SC, ST, & OBC need not produce any income certificate/ file declaration.
2. An applicant admitted under Category 1, 5, 6 & 8 shall have to produce an income certificate in original as per Clause 7.06 under Certificates & Testimonials.
3. An applicant admitted under Category 1, 5, 6 & 8 who is unable to produce the required income certificate shall pay the full fee at the time of admission. He may submit the same within 60 days from the date of admission and claim refund/ adjustment from the institute.
